BEFORE YOU TIE THE KNOT

This is a premarital class that provides a certificate worth \$32.50 reduction of the fee for a marriage license obtained in Alachua County. The program consists of two workshops, each lasting 2 hours. Participants must attend both sessions to receive a certificate of completion.

These Extension workshops fulfill the requirements of Florida Statute 741, Marriage Preparation and Preservation Act, and have been approved by the Circuit Court of Alachua County.

Registration is due no later than one week prior to class. A minimum of three couples must be registered or class will be cancelled. Please call (352)337-6209 (voicemail) to register. For more information, call (352)955-2402 between the hours of 8:00 a.m. and 4:30 p.m., Monday through Friday.
